3. Membership Structure — Presented by Lynn Richards (President & CEO)


**Discussion:** Why Did you become a CNU Member? And Why have you remained a CNU Member?


<u>Michaele Pride—</u> because a member because the principles are relevant and durable—the practitioners have passion, dedication, and tackle urban issues holistically.

## 4. Fee for Service — Presented by Lynn Richards (President & CEO)

**Proposal:** In October, Lynn Richards (President & CEO) asked the Board for guidance on how to compensate Members for the work they do for CNU. An Ad-hoc committee was created to develop guidelines—they propose the following:

- CNU should not engage in any work that could have reasonably been completed by a CNU member or member firm.
- CNU should focus its energies on creating or doing work that would not happen in the private market and by doing so CNU may be creating work for our members.





• Throughout all of our programs, CNU seeks to 1) ensure transparency in the selection process and compensation structure, 2) increase diversity in team and member selection, and 3) build a deep bench of CNU talent, subject matter experts, and leaders.

**Discussion:** Lynn Richards will continue to revise and develop these principles under the guidance of the Executive Committee.

## 5. Training and Education Center — Presented by Nathan Norris (Director of Training & Education)

**Discussion:** As Director of Education and Training Programs, Nathan Norris will lead the organization's outreach to cities and expand its municipality-focused training and education. In addition to managing CNU's intensive Core Curriculum workshops, Norris will oversee new technical offerings on a range of New Urbanist topics like coding, development, street design and more. Available to state and local governments of all sizes, CNU's educational programs offer a crash-course for municipal leaders and staff on New Urbanist principles and strategies.

## 6. Nominations Committee Update — Presented by Eliza Harris Juliano (Chair Elect)

**Proposal:** One renewing Board Member will accept a 2 year term (for which there is already a volunteer) and that two of the new 2017 appointments accept an initial 2 year term with the opportunity for a typical 3 year renewal. The Board will be one seat short (11 total) in 2018, but the schedule will remain relatively consistent and measured in its annual turnover ratio.
